## **PRODUCT DESCRIPTION AND USE**

SunH2O is water based, non-acid polymer bonded stains that penetrate and adhere to the concrete surface to produce vibrant long lasting UV resistant stains that enhance any concrete surface. SunH2O contains no arsenic, lead, or mercury and very low organic solvents that conform to all VOC regulations.

## Packaging

1 and 5 gal color packs that mix with 1 and 5 gal base stain containers.

#### **Surface Preparation**

Concrete must be clean and structurally sound. Substrate must have adequate profile for subsequent sealers to obtain good adhesion.

#### **Application Recommendations**

SunH2O is normally applied at 200-300 sq. ft. per mixed gallon and may be sprayed using low pressure sprayer, HVLP or air brush. When diluted with water will produce a floor with more variations in tone.



A brush can be used for small areas. Do not over apply and do not allow it to puddle. Allow floor to dry thoroughly. Drying time will vary according to the surface conditions and humidity.

#### **Handling Precautions**

Use appropriate cartridge-type respirator.
